CONTINUING OUR FOCUS ON NEGLECT

We are continuing our focus on **Neglect** and have updated some of our resources to help with improving identification and interventions where we are concerned about a child's quality of care. These can be found on the SSCP website [here](#).

There is still considerable progress needed to increase use of the **GCP2 tool** across all partners, and in particular and we are keen to hear from all teams, to help identify Practice Leads who can support and encourage others in their teams to use the tool. The responsibilities of this role are described below.

GCP2 Practice Leads

- Be positive advocates for the use of GCP2.
- Have used GCP2 at least once and be regularly using GCP2.
- Demonstrate good GCP2 practice and understanding.
- Promote the principles of the use of GCP2 within their teams.
- Support colleagues within their team/s to use GCP2 through general advice and mentoring.
- Support colleagues within their teams to use ECINS.
- Attend briefing sessions (1 hour every 2 months) to discuss GCP2 project, feedback key messages to and from teams and network with colleagues from across the partnership

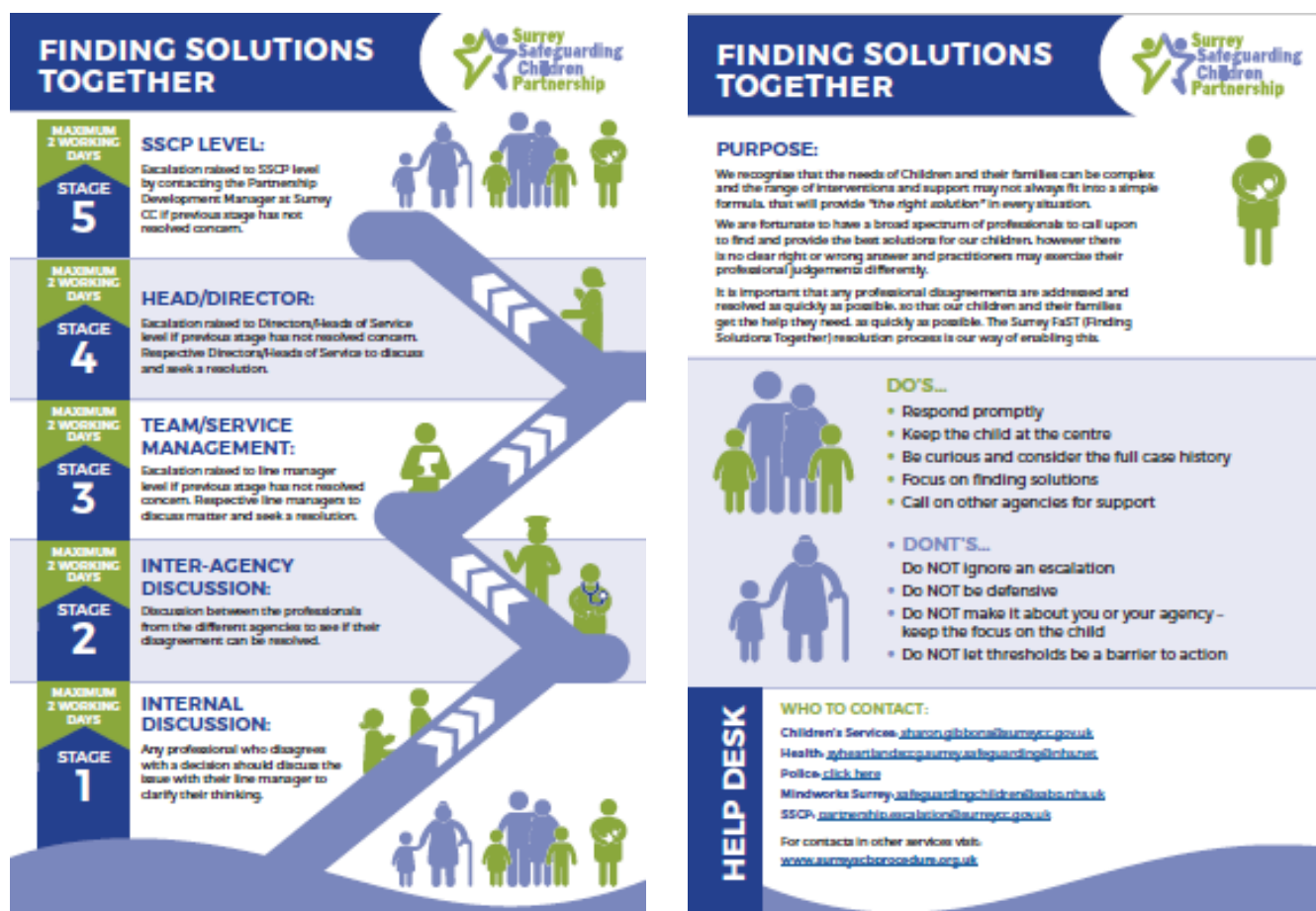


SSCP Finding
